**Waiver of Liability and Operation Agreement**

I agree to follow all instruction and conform with the listed terms and conditions as stated, and **“assume full responsibility”** for the listed equipment and **“full liability”** for any damage caused or incurred by any property or person during transport or operation of said equipment.

1. Unless otherwise state, price quoted applies to a use period not to exceed 2 hours from the time of contract. Additional time accrued will be charged at a rate of \$25/hour or any part thereof until time of return.
2. If you are taking a mixer out close to closing time and return mixer after posted business hours, a minimum late fee of \$100.00 will be assessed.
3. User is required to return equipment clean of any excess product or water. Any cleaning or disposal of product remaining in equipment will be charged against deposit with a minimum assessment of \$25.00.
4. Trailer hitches (if rented) and drum covers must be returned with trailer, make sure they are checked off upon returning them. If not returned a minimum \$100.00 charge will be assessed for either.
5. Equipment provider is not responsible for shortage caused by untimely unloading, (1 to 2 hrs), Mis-measurement of material requirements, or inferior forms.
6. Never unhook trailer or turn motor off when there is concrete in the trailer.
7. It is User responsibility to check all hitches, safety chains, electrical connections and light function prior to leaving yard.
8. User should do a walk around to inspect the condition of the trailer itself, any damage not reported prior to departure will be presumed to have occurred during rental use and be the liability of user.
9. Any charges will first be deducted from deposit and balance collected from user.
